**Comments by Robert A. Gladstone, Chair
TCNJ Board of Trustees
October 12, 2000**

Good afternoon.

I have opened each Board meeting during my Chairmanship by sharing with you some thoughts that were on my mind. This is my last meeting as Chairman, and I have no reason to depart from that pattern. In fact, today's opening may be a little longer than most. I hope you will bear with me.

I want this Board and those of you who were kind enough to attend this meeting to know that I feel as good about what we have all accomplished here in the last few years as I do about anything else I may have accomplished in public service. Sometimes it's difficult to remember back to the days of turmoil and distrust among those of us who have had the privilege of sharing the heart of this wonderful institution. We have come as far as we have through a very simple formula: dedicated people of good will working selflessly toward a common goal.

We enjoy a faculty that was insistent, but thoughtful, caring and willing to trust some strangers, when despite early billing, we appeared to have the best interests of The College at heart. I and The College community thank you and admire you for that.

And thanks and admiration go out to the administration, the staff and the working men and women who make this institution the gem that it is. Thanks especially to Heather Fehn, whose cheerfulness, optimism and competence have helped to hide my missteps and flaws. I recall the days when I looked across the table from some of our highest level officials. They looked back at me as if to say, "who is this guy – what's he all about – and he better not get in the way of things". Despite their understandable concerns, they continued about their business professionally and admirably, and we are all beneficiaries of their efforts.

I look with admiration and thanks to our talented student body, who grilled Walter and me at an SGA meeting, and tested our grit and determination to keep The College moving in the right direction. It may surprise some of you to learn that we weren't always absolutely certain that we were doing the right thing. Fortunately, the students don't allow a little uncertainty to interfere with a good party.

My thanks to President Eickhoff. Many of us in this room disagreed with Harold Eickhoff sharply on some pivotal issues. Whatever – and whoever – was right or wrong in those days is inconsequential today. No-one can deny the enormous contribution Harold has made to this college. He serves The College today with dignity as a distinguished professor and our thoughtful colleague.

Let me turn to our exceptional Board of Trustees, and offer them my sincere personal thanks for their unwavering support, and the thanks of this college and of all the men and women who constitute our extended family. This Board is not a board of stuffed suits. It's a Board with individuals who care mightily about The College. When The College needed strength, the Board debated, considered and decided upon a course of action. It knew that it must be resolute in support of the decisions it made. There were difficult times - and times when men and women of lesser character might have retreated

from the bold positions they knew must be taken. This Board stood united and courageous.

How comforting it was to me to know that even those who may have disagreed with my position stood resolute behind the positions we took as a body. Such diversity of background, ethnicity and interest coming together with dedication toward a shared commitment. And as the dust settled, how rewarding it was to see the administration, the faculty leadership and the academic deans put aside differences, distrust and ego toward a common goal – now achieved. As time went on, our Board was blessed and strengthened by the addition of several new members – all energetic, intelligent, enthusiastic and dedicated to the well being of our college.

There are three friends of mine – and of yours – who I need to single out and thank by name.

I have known Jesse Rosenblum for many years. During that time, I confess I sometimes grew weary of listening to Jesse tell me about how extraordinary this college was. So I decided to become a member of the Board to see if he was telling the truth. He was. Jesse, thanks for your encouragement.

It is hard to say too many positive things about Walter Chambers. When this college needed a leader with stature and ability – a conciliator, a facilitator and a just plain trustworthy, decent person - we looked to Walter. He came through: big time! Walter guided us through the difficult days of presidential transition, and led the happy and successful search for my next friend – President Barbara Gitenstein.

I couldn't begin to recite all the wonderful things there are to say about our President, Bobbi. You probably know them better than I do. Suffice it to say that I am proud to be associated with an institution over which she presides. I am even prouder of the fact that she came to us on my watch.

I have a sneaking suspicion – and this is a bold prediction – that my friend Walter may be the next Chairperson of this Board. With Walter Chambers as Chair of the Board, Barbara Gitenstein as your college President, Steve Briggs as your gifted provost, and with the collective wisdom of this wonderful campus community, I predict serious competition for that other college up Route 1 when the next ratings are published in the U.S. News and World Report.

It has been my privilege and my pleasure to serve this college. I leave this position knowing that you are in the absolute best of care. I look forward to a continuing relationship with all of you.
